Craig turned the meeting over to Mike Carey and Eric Bryant from Charlie Norwood VA Medical facility.

Mike was curious about where MAVA vets were getting their medical needs attended and presented a proposed VA Medical clinic in Athens. He went on to say the VA is pushing hard for medical staffers at the facilities. The VA trains more medical professionals than any other organization.

Mike mentioned there are around approximately 1200 vets in the area and only a small percentage are signed into the system. An interesting statistic is every time a new vet signs up for services \$3500 gets allocated in additional benefits for that area. He was asking for our cooperation to have an open house with the many divisions of Charlie Norwood in attendance. Example: Suicide prevention, pharmacy, benefits, etc. Jim Brady offered the Cotton Gin as the venue since it would offer a central location and a good time would be in the fall.

Some of the vets expressed concern over the phone system and both Mike and Eric confirmed this is the #1 complaint about the system.

A Cliff notes version would be something like:

The PACT Act is perhaps the largest health care and benefit expansion in VA history. The full name of the law is The Sergeant First Class (SFC) Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act.

The PACT Act will bring these changes:

- Expands and extends eligibility for VA health care for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and post-9/11 eras
- Adds 20+ more presumptive conditions for burn pits, Agent Orange, and other toxic exposures
- Adds more presumptive-exposure locations for Agent Orange and radiation
- Requires VA to provide a toxic exposure screening to every Veteran enrolled in VA health care
- Helps us improve research, staff education, and treatment related to toxic exposures

If you're a Veteran or survivor, you can file claims now to apply for PACT Act-related benefits. You can also call 800-698-2411 (TTY: 711). And you can file a claim for PACT Act-related disability compensation or apply for VA health care now.
