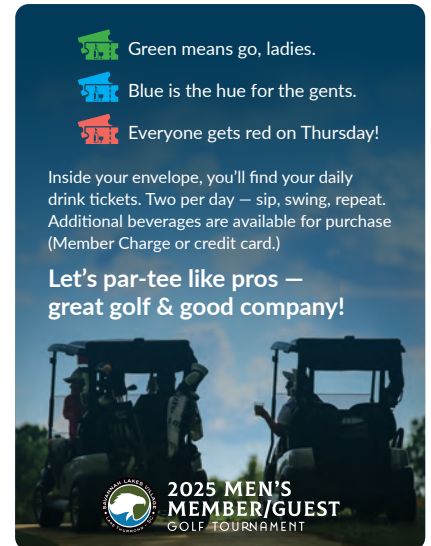
Players and spouses/significant others will receive beverage tickets upon check-in Thursday. The Member/Guest package includes the following for each person:

Late Arrivals for Tee Times

If a team is late for the shotgun start, they may join in on the next tee box. Points will be forfeited for any hole missed by any player or team.

Missing Player or Team Cancellations

If a player cannot play, his teammate can compete as a one-man team. If a team cancels, a spotter team and or player will be assigned as score keepers for the other competing team.

Championship Shoot-Out – 3 Holes

The five flight winners will compete in a 3-hole shoot-out with eliminations at each hole, leaving only two teams to compete on the final hole to determine the overall Champion. Team scoring in the shoot-out will be the combined net score of the two players. If needed, we will have elimination tie breakers. Elimination will be decided by chip-off. Closest to the pin wins.

This year's shoot-out holes will be Tara #10, #18 and #9.

- **10** – Two teams will be eliminated.
- **18** – One team will be eliminated.
- **9** – The remaining two teams will compete and the winning team will be the overall Champion.

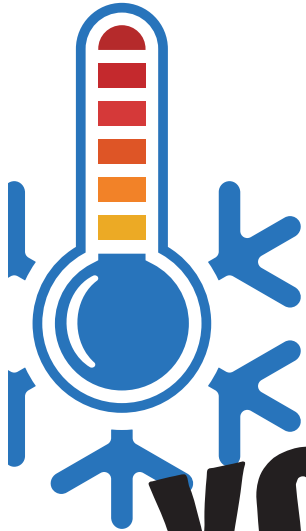

Practice Round and Tournament Rules

All Play is Governed by the USGA Rules and Local Rules.

- Lift, clean and place within the width of the scorecard no nearer the hole, in your own fairway.
- The “one ball rule” is NOT in effect for the practice round or event.
- There is no rock or root rule for this event.
- In case of inclement weather, play will commence and or continue, unless The Committee or Superintendent deems the course to be unplayable.
- All putts must be holed out unless you have picked up because of a net double bogie.

Highlighted Local Rules

This information covers the most important local rules here at Savannah Lakes.



SLV Local Rules: Highlighted Revisions

2025

Please read these revisions to the SLV Local Rules.

RED PENALTY – NO-PLAY ZONES The red penalty area defined by red stakes with green tops on the left side of the Tara green on hole 9 is a No Play Zone that is treated as a penalty area. The entire area covered in pine straw defines this Red Penalty – No-Play Zone. Players must take relief from interference by the No-Play Zone and proceed to the Drop Zone with a one-stroke penalty.

BORDERED LANDSCAPE AREAS – NO-PLAY ZONES Bordered Landscape Areas on Tara holes 4, 10, & 9/18 and Monticello hole 6 are designated No-Play Zones that are treated as Abnormal Course Condition. Without penalty, players must take complete relief no closer to the hole.

DROP ZONES For Tara #9, balls entering the penalty area bordered by the railing beside the cart path, with a one-stroke penalty, the player may drop in the rough on the opposite side of the cart path no closer to the hole.

RETAINING WALLS The course side edge of the retaining wall on Tara #18 & edge of the Tara Overlook define the boundary of the course. Relief from the boundary object/retaining wall is not available. When the ball lies on the river rock between the cart path & the retaining wall on Tara #18, players may take relief without penalty across the cart path no closer to the hole.

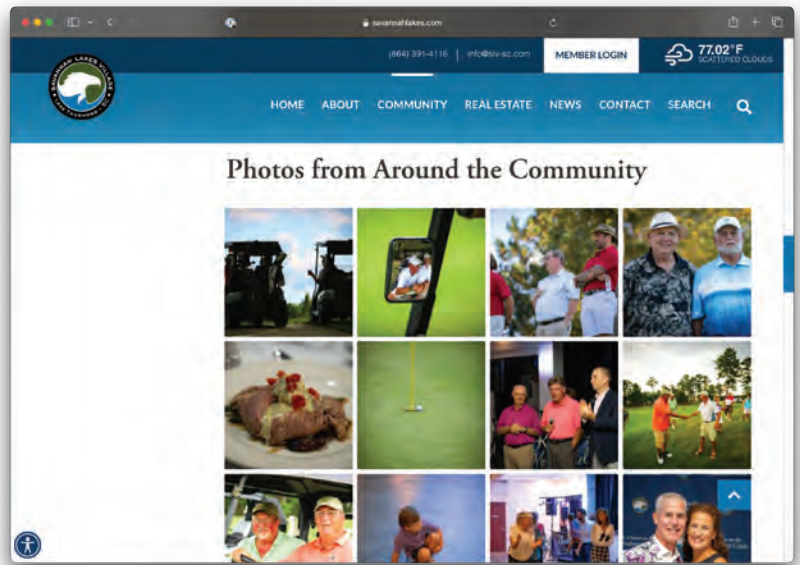
