Flight winners will be determined by the teams with the highest Net Stableford points. Ties for the flight winners will be determined by a chip off conducted by a committee member.

Late Arrivals for Tee Times

If a team is late for the shotgun start, they may join in on the next tee box. Points will be forfeited for any hole missed by any player or team.

Missing Player or Team Cancellations

If a player cannot play, his teammate can compete as a one-man team. If a team cancels, a spotter team and or player will be assigned as score keepers for the other competing team.

Championship Shoot-Out – 3 Holes

The five flight winners will compete in a 3-hole shoot-out with eliminations per hole, leaving only two teams to compete on the final hole to determine the overall Champion. Team scoring will be the combined net score of the two players. Tie breakers for elimination at each hole will be decided by a chip off. Closest to the pin wins!

Practice Round and Tournament Rules

All Play is Governed by the USGA Rules and Local Rules.

- Lift, clean and place within the width of the scorecard no nearer the hole, in your own fairway.
- The “one ball rule” is NOT in effect for the practice round or event.
- There is no rock or root rule for this event.
- In case of inclement weather, play will commence and or continue, unless The Committee or Superintendent deems the course to be unplayable.
- All putts must be holed out unless you have picked up because of a net double bogie.

Local Rules

Double Green

If a ball comes to rest in an area of the putting surface on the 9th or 18th green at Tara where it is impossible to play the shot with a putter, the ball **MUST** be lifted, carried off the putting surface, and placed without penalty on the fringe of the green no nearer the hole, and chipped or pitched from there.

Retaining Walls

This applies to the following holes: Tara #9 and #18; Monticello #4, #5, #11, #12, and #17. If the retaining wall interferes with a player's stance or swing, the ball may be lifted and placed, without penalty, within one club length from complete relief of the original position in like conditions, no nearer the hole. Under no circumstances may the ball be placed on the putting surface.

Interior Streets

A ball coming to rest on or crossing any interior street is considered to be out of bounds.

Distance Measuring Devices

Distance measuring devices are permitted provided that these devices measure distance only.

Stones Around Drainpipes

Stones placed around drain openings are considered part of the drain. The player will receive stance and swing relief of one club length, no closer to the hole.

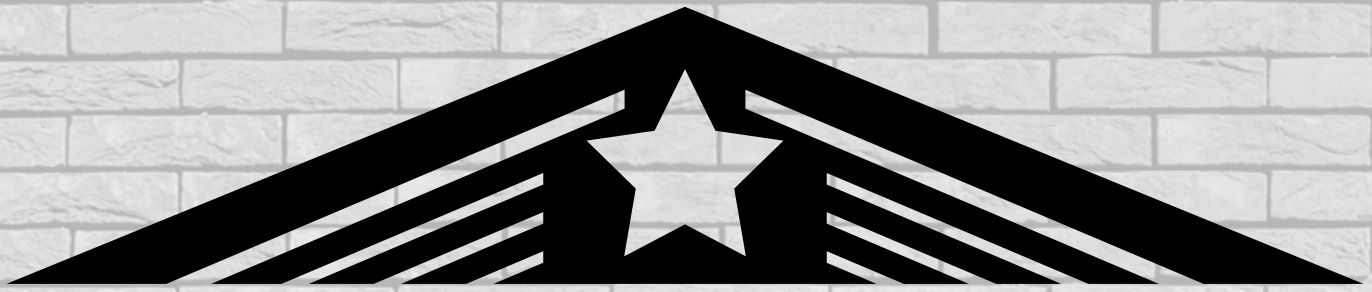
